The Clearfield E.M.S. ambulance membership plan covers medically necessary emergency transports & medically necessary transports to the closest appropriate hospital according to medicare guidelines. The plan covers any uninsured portion of a claim, insurance co-payments, and deductibles for every member of your household at an affordable rate. Members can use the Area Transportation Authority's wheel chair vans, for medical transports, for FREE, restrictions apply-call for details. The membership is not an insurance policy.

Open enrollment is from May 15th through June 30th. Memberships received after June 30th will be subject to a 30-day waiting period.
